Pupil Premium Funding 2016 - 2017

Since the introduction of the Pupil Premium in April 2011, schools are required to report to parents how their Pupil Premium allocation is spent and the impact that this money has.

The pupil premium is additional funding for publicly funded schools in England to raise the attainment of disadvantaged pupils and close the gap between them and their peers. It is a sum of money derived from the number of children eligible for free school meals, service children, adopted children and Looked after Children (LAC), defined in the Children Act 1989 as one who is in the care of or provided with accommodation by an English local authority. It is in addition to main school funding.

For the 2016-2017 financial year (based on the January census) this amount is £1320 for each child eligible for Free School Meals (FSM), £1950 for those in the care of the local authority (LAC) and £300 for each child with a parent in the armed services.

At Hipsburn Primary School this sum comes to £14,140

The allocation of pupil premium funds is reviewed annually by the school so that it can be used to the greatest benefit. Schools are free to spend the Pupil Premium as they see fit, but are accountable for the success of their chosen expenditure.

What do we aim to do?

We ensure that necessary and challenging provision is made for pupils who belong to vulnerable groups, this incudes ensuring that the needs of disadvantaged pupils are appropriately assessed and addressed.

We ensure that Pupil Premium funding follows identified needs. This may mean that not every child who receives Free School Meal will be in receipt of Pupil Premium funded interventions all of the time.

We ensure that teaching and learning opportunities address the needs of all pupils.

We recognise that there are disadvantaged pupils who do not qualify for Free School Meals, the Forces Premium or Pupil Premium Plus. As a school we allocate resources to support any group or groups of children we have identified as being disadvantaged or vulnerable.
